PROGRAMME GOAL


➤To minimize the impacts of climatic and economic events on smallholder farmers while supporting sustainable market access for their produce

DEVELOPMENT OBJECTIVES


- ➤To build overall resilience to climate change by adopting climate resilient practices;






Eight (8) Organizational Development Plans (ODP's) have been developed for farmers' organizations.


- ➤The implementation of capacity building activities related to the ODP's are ongoing with trainings being carried out in 8 communities.
- ≻2021-22 Target is for an additional 12 ODP's to be developed for 12 PO's.
- Four (4) Business Plans have been developed for investments.
 - ➢Three (3) have been approved (Belize \$227K; Cayo \$224.8K; and Toledo \$238.3K)
 - >One (1) Matching Grant Fund Agreement has been signed, however implementation has been delayed.
 - >2021-22 Target is for 12 Businesses Plans to be developed for 12 PO's, and implementation of 16 MGF.

Current Programme Status: Component 1

BYG # 1 Assistance:

- > Four hundred sixty-two (462) households have benefited.
- Distributed more than five thousand (5000) Rhode Island Red or Black sexlink baby chicks.
- > Distributed over Twenty thousand (20,000) vegetable seedlings.



Current Programme Status: Component 1

BYG#2 Assistance:

- Currently working on an experimental design required by the Green Climate Fund to scientifically measure the impact on the targeted beneficiaries.
- ➢six hundred twenty-nine (629) household applications completed to date. Targeting 2000 household application by July 2021.
- Implementation is expected to commence in August 2021.

CAPACITY BUILDING

- Gender Equality Training for 35 people (MOA, Coop dept and RRB).
- Training in climate-resilient agricultural practices will commence in July for 30 officers/technicians. (Training to be done by CATIE)
- Capacity Building to strengthen the Department of Cooperatives.
- Young Managers' Pilot Program
- Capacity building to strengthen BMDC and BOS in quarter 2.
- Procure Equipment for a CIS to be managed by NMS.

Programme Components

Component 2: Climate Resilient Rural Infrastructure and Assets

Rural Roads Improvement Small bridges, drainage facilities, culverts, retaining walls and other erosion protection works

Small Scale Irrigation and Drainage

- Intake structures such as pumping station and rain water harvesting ponds
- Drainage network and flood protection structures

Territorial Climate Resilient Assets (CIS)

- To collect, monitor, analyse and exchange climate related information
- To provide farmers with accurate and timely climate-related information
- To provide an effective means of disseminating information to farmers (Radio, TV, Cell Phones)
